The mission of the 100 Club of Arizona is to provide immediate financial assistance to the families of public safety officers and firefighters who are seriously injured or killed in the line of duty, and to provide resources to enhance their safety and welfare.

### **LINE OF DUTY DEATH • ON-DUTY DEATH • NON-LINE OF DUTY DEATH**

Financial assistance is provided to the families of public safety officers and firefighters following a death.



### **LINE OF DUTY INJURY**

In addition to one-time financial assistance for serious injuries, monthly stipends are provided to those who are out of work for extended periods of time (a minimum of 30 days) due to on-duty injuries.



### **HEROES**

One-time financial assistance is available for first responders affected by terminal illness, cancer, the loss of a spouse or child, or a life-altering event.



### **INJURY PREVENTION**

This program helps agencies obtain essential equipment and training that may not be available through existing resources.



### **SCHOLARSHIPS**

Undergraduate financial education assistance is available for immediate family (spouses and children) of active, retired, or deceased Arizona public safety officers and firefighters.





## PEER 100 TRAINING SUPPORT

Bring wellness training to departments across Arizona. Our goal is to support group training on resiliency, peer support programs, nutrition, financial wellness, family support, sleep deprivation, stress management, mindfulness, suicide prevention, and more.



## BULLETPROOF/FIREPROOF

A confidential health and wellness app for law enforcement and fire agencies, non-sworn personnel, and their families. Includes customizable options for each agency.



## PEER 100 ASSISTANCE

Support for mental health prevention and intervention services for first responders struggling with the impact of their public safety work.



## RETIREEE TRANSITION ASSISTANCE

Support for mental health prevention and intervention services to help retirees successfully transition into and thrive in retirement. Assistance is available for up to 24 months after retirement.
